The Department of Medicine is one of the four departments within the School of Health Sciences at Aristotle University of Thessaloniki. It was founded as the Medical School of Aristotle University of Thessaloniki in 1942 during the German Occupation of Greece. In 2013, the Medical School was renamed the Department of Medicine within the School of Health Sciences.

The primary educational objective of the Department is to impart ethical values governing the practice of the medical profession and to ensure the acquisition of scientific knowledge that will enable students to effectively diagnose and manage general medical issues they will encounter after graduating from the Department.

Simultaneously, the faculty members of the Department contribute to hospitals and other Public Health units, thereby contributing significantly to societal well-being.

The Department offers a total of (41) organized Postgraduate Programs, eight of which are Interdepartmental / Interinstitutional programs with the Department of Medicine at Aristotle University of Thessaloniki (AUTH), while it also participates in (4) other Interdepartmental / Interinstitutional Postgraduate Programs as a collaborating department.

Organizationally, it consists of 6 Sectors: Radiology, Anatomy, Pathological Anatomy and Technologies; Physiology, Pharmacology, Biological Sciences & Preventive Medicine, Pathology, Surgery, Child Health and Neuroscience and Sensory Organs.

Quantitatively and qualitatively, the Department of Medicine at AUTH is one of Greece's most significant and established schools, with the largest student enrollment in the country, hosting more than 4,000 registered students, 58 clinics, and 26 laboratories.

GENERAL INFORMATION ABOUT THE MASTER'S PROGRAM

Master's Program

Title: "**Forensic Medicine, Forensic Psychiatry**"

Director Mr. Fotios Chatzinikolaou

By decision of the Senate of AUTH No. 3043/23-12-2020, the Master's Program titled "Forensic Medicine, Forensic Psychiatry" was established under the Department of Medicine, School of Health Sciences, AUTH.

The program was organized and initiated in the academic year 2020-2021, awarding a Master's Degree with the title "MSc in Forensic Medicine, Forensic Psychiatry" and provides a unified curriculum.

The program aims to educate postgraduate students in the modern scientific developments in Forensic Medicine and Forensic Psychiatry. It aims to provide education to healthcare professionals, legal experts, and members of security bodies involved in monitoring the physical and mental health of individuals, with the responsibility of ensuring peaceful and unobstructed social living.

The **main objectives** of the program are as follows:

- To provide knowledge in Forensic Medicine and Forensic Psychiatry.
- To acquire knowledge and skills in managing the dangerousness, violence, and related behaviors of mentally ill individuals.
- To create professionals with the necessary skills for successful careers in private, public, and academic sectors.

The **broader operational objectives** of the Master's Program aim to:

- Establish a strengthened framework of collaboration with Universities and Research Centers in Greece and abroad.
- Showcase the research work of students at international and Greek conferences.
- Attract candidates from other Universities in Greece and abroad.

Competent bodies for the administration, organization, and operation of postgraduate programs include:

- The Senate of the Institution, responsible for academic, administrative, organizational, and financial matters of the Master's Programs, except those explicitly assigned by law to other bodies.
- The Coordinating Committee, consisting of five (5) members of the Academic and Research Staff of the Department of Medicine, who are engaged in postgraduate work. They are elected by the

Assembly for a two-year term and are responsible for monitoring and coordinating the operation of the Master's Programs.

- The Program Director of the Master's Program, who is a member of the Coordinating Committee and is appointed along with the Deputy Director by decision of the Department of Medicine Assembly.
- The six-member Scientific Advisory Committee of the Institution, responsible for the external academic evaluation of the Master's Programs.
- The Admissions Committee of the Master's Program, which is composed of three (3) members of the Academic and Research Staff who belong to the Coordinating Committee of the Master's Program. It is responsible for document verification, the selection process, and ranking candidates based on criteria, and it recommends the list of successful candidates to the Department of Medicine Assembly for approval.

Administrative support for the Master's Program is provided by the Department of Medicine AUTH and external partners. The Administrative Office of the Master's Program is responsible for the administrative organization of the MSc, the maintenance of files and grades of postgraduate students and the procedural aspects of enrollment. It also informs postgraduate students about matters related to the organization and operation of the Program, **through their institutional account / @auth.gr.**

The teaching of courses in the Master's Program "Forensic Medicine, Forensic Psychiatry" is **conducted using the existing infrastructure of the Department of Medicine, AUTH.** The observation of clinical cases takes place in the facilities of AUTH, under the supervision of instructors. This includes the analysis of relevant incidents.

DURATION AND TERMS OF STUDY IN THE MASTER'S PROGRAM / ACADEMIC CALENDAR

- The duration of enrollment in the Master's Program leading to the award of the Master's Degree is set at three (3) academic semesters, including the completion of the Master's Thesis.
- Postgraduate students must successfully complete their studies, including the preparation and submission of the thesis, by the end of the 3rd semester. Upon proposal by the Coordinating Committee of the Master's Program and decision of the Assembly, the duration of enrollment or/and the time for thesis preparation and submission **can be extended** by one (1) year.
- **Temporary suspension of studies**, up to two (2) consecutive semesters, may be granted to postgraduate students upon submission of a relevant application. During the suspension period, the student loses their student status, but this time is not counted toward the maximum duration of regular enrollment. Upon resuming studies, postgraduate students return to regular student status with all the rights and obligations stipulated in the Master's Program.
- Exceptionally, and only in cases of illness, work burden, severe family reasons, military service, reasons of force majeure, an extension of studies up to one year can be granted, following a reasoned decision by the Department Assembly.
- Applications by postgraduate students for partial enrollment, suspension, or extension of studies must be submitted before the start of the academic semesters.

The decision regarding withdrawal is made by the Department Assembly upon a proposal from the Coordinating Committee. The grounds for withdrawal include:

- a) Inadequate progress of the postgraduate student (evidenced by a lack of participation in the educational process, such as attendance and exams).
- b) Manifestation of behavior that violates academic ethics, such as plagiarism.
- c) Request from the postgraduate student.

- The MSc program provides the opportunity for course reevaluation:

If a postgraduate student fails an exam or exams and is considered not to have successfully completed the program, they **can be reevaluated upon request** within ten (10) days from the end of the examination period of the specific semester in which they failed. The reevaluation is conducted by a three-member committee of faculty members of the School of Health Sciences of AUTH, with members having the same or related academic subject as the examined course. The committee is

appointed by the Department Assembly of the Medical School, excluding the examiner, who is the instructor.

For matters of course reevaluation in overdue courses, the Department Assembly decides upon a proposal from the Coordinating Committee, determining the conditions of the reevaluation as specified in the Master's Program Regulations.

- If a postgraduate student fails an examination of a course or courses and is considered to have not successfully completed the program, they can **request a re-examination** within ten (10) days from the end of the examination period of that specific semester. The re-examination is conducted by a three-member committee consisting of members of the School of Health Sciences Teaching and Research Staff, with expertise in the subject matter of the course being examined, appointed by the Department Assembly. The instructor in charge of the course is excluded from the committee.

For matters of re-examination in outstanding courses or deletion, the Department Assembly decides, based on the proposal of the Coordinating Committee, the terms of re-examination, which are included in the Master's Program Regulations.

- Postgraduate students are enrolled and participate in the Master's Program under the terms and conditions set forth in the Regulations of the Master's Program. Postgraduate students have all the rights, benefits, and facilities provided for undergraduate students, except for the provision of free textbooks.
- The Master's Program co-operating with the Department of Medicine, as part of its **social policy**, provides accommodations for graduate students with disabilities or special educational needs. Access to examination rooms and teaching laboratories is facilitated with special ramps and elevators. The Department of Medicine buildings have accessible restrooms for people with disabilities. Examinations/presentations for students falling under the aforementioned category are conducted either remotely, orally, or in a room with accessibility for people with disabilities.
- The Regulations of the Master's Program specify the requirements necessary for successful program completion and the award of the Diploma.

For the final evaluation and grading of the performance of postgraduate students in their courses, the following are taken into consideration:

- Distance learning / Physical presence in classes.
- Their performance in an assessment determined by the instructor, whether in oral or written exams, bibliographic assignments, research projects, or a combination of the above.

The grading scale for evaluating the performance of postgraduate students is defined from zero to ten as follows: Excellent (8.5 - 10), Very Good (7 – 8,49), Good (6 – 6,99). A passing grade in the examinations of the courses of the postgraduate program and in the master's thesis is defined as equal to or greater than **6**.

The Master's thesis is subject to **plagiarism detection**. When submitting any postgraduate work, the postgraduate student is required to indicate if they have used the work and opinions of others, as well as the bibliography, following scientific work standards.

Copying is considered a serious academic offense. Plagiarism is considered the copying of another's work, as well as the use of someone else's work - published or not - without proper attribution. Quoting any material for documentation, even from the student's own studies, without proper referencing, may result in a decision by the Coordinating Committee, for expulsion.

In the above cases - and following a reasoned proposal from the supervising professor - the Department Assembly may decide on the student's expulsion.

The instructors of the courses check all the submitted assignments of the students on the Turnitin platform or in e-learning for plagiarism rates, in order to determine and grade accordingly.

Any offense or violation of academic ethics is referred to the Coordinating Committee of the Master's Program for assessment and recommendation for addressing the problem in the Department Assembly. Violations of ethics and study quality rules, including cases of copying or plagiarism and, more broadly, any violation of intellectual property provisions by postgraduate students during the preparation of assignments within the courses or the completion of the postgraduate thesis, fall under the jurisdiction of the Ethics Committee of the Institution.

After the submission and presentation of their master's thesis and before their graduation is scheduled, postgraduate students are informed by the Secretariat of the Master's Program for the submission of the required documents, such as:

- Copy of the master's thesis to the Central Library
- Submission of their academic identification

- The academic year begins on September 1st and ends on August 31st of the following calendar year.
- The educational activities for each academic year are structured into two semesters: the winter semester and the spring semester. Each semester consists of 13 weeks of instruction and one or two weeks of examinations.

- The winter semester begins in the second or third week of September and ends in early January. It's followed by the first examination period of the winter semester.
- The spring semester starts in mid-February and ends in late May. It's followed by the first examination period of the spring semester.
- The exact dates are determined by the relevant authorities. However, in exceptional cases, the Minister of Education, upon a proposal from the Senate, adjusts the start and end of the two semesters outside the normal dates in order to complete the necessary 13 weeks of teaching for each semester.
- Each semester has two examination periods:
- Courses in the winter semester are examined during the period of December to January and again during the period of September, after the completion of the academic semester.
- Courses in the spring semester are examined during the period of June and again during the period of September.
- The examination periods of December-January and September last for three weeks, while that of May-June, according to the law, lasts for two weeks. However, they usually extend over a longer period of time.
- Before the start of each examination period, students have the right and obligation to evaluate their courses and instructors, aiming to improve the quality of their studies. More information is available on the website of the Quality Assurance Unit (MODIP-AUTH <http://qa.auth.gr>) and on the website of their School/Department.

BREAKS

During the months of July and August, no classes or examinations take place, and these months are considered summer vacation. Additionally, the following breaks are included:

- *Christmas Break:* From December 24th to January 7th.
- *Carnival Break:* From the Thursday of Carnival to the day after Clean Monday.
- *Easter Break:* From Easter Wednesday to the Sunday of Thomas.

HOLIDAYS AND OFF-DAYS

- *October 26th:* Celebration of the city's patron, Saint Demetrius. Thessaloniki's Liberation (National Holiday).

- *October 28th*: "OXI" Day - Anniversary of the Greek refusal to the Italian fascism (National Holiday).
- *November 17th*: Anniversary of the Polytechnic uprising in 1973.
- *January 30th*: Feast of the Three Hierarchs (Religious Holiday).
- *March 25th*: Anniversary of the Greek Revolution of 1821 against Ottoman rule (National Holiday).
- *May 1st*: International Workers' Solidarity Day (Labor Holiday and Strike).
- *Pentecost*: Mobile religious holiday.

PROGRAM STRUCTURE

The Master's Program in "Forensic Psychiatry - Psychiatric Forensics" offers an integrated curriculum structured into two (2) full-time academic semesters, with the third semester dedicated to the completion of the master's thesis. The program consists of seven (7) compulsory courses in the 1st semester and seven (7) compulsory courses in the 2nd semester. Throughout their studies, master's students are required to:

- Attend and successfully pass the taught courses.
- Participate in clinical laboratory research and clinical cases, if it's possible.
- Complete a master's thesis, which can be either a review or research work.

The academic year starts in October of each academic year and concludes in June of the following year. The examinations for the corresponding courses of the program are held during the last two weeks of both the 1st and 2nd semesters. The master's theses are carried out during the 3rd semester, from mid-September to the last ten days of January.

The **language of instruction for the program is Greek**, and the language for completing the master's thesis is also Greek. To obtain the Master's Degree, master's students are required to accumulate 90 ECTS credits.

The start and end dates of courses, as well as the duration of examination periods, are determined by the academic calendar or through decisions made by the Program Studies Committee. These details are published on the Department's and the Master's Program's websites.

All courses of the 1st and 2nd semester are conducted with 90% distance learning, via zoom application and 10% physical presence, as they are mentioned above, depending on the needs and availability of instructors. The courses are registered on the e-learning platform, which provides

master's students with access to announcements from instructors, educational material, and submission of assignments. The registrations/settings on the e-learning platform for all the above are managed by the respective Director of the Master's Program.

The duration of each semester's program is thirteen (13) weeks and is comprised of weekly lectures of either one or two hours, along with intensive seminars involving assignment submissions, tailored to the course requirements and the instructor's preferences.

CONTEXT OF COURSES

1st Semester

1. **Forensic Medicine - General Framework - Histology – Pathological Anatomy:** General and Special Theories and Principles of Forensic Medicine and Related Specialties, from Theory to Practice. Often, cells are diverted from their normal function or contaminated by external factors, leading to the development of various diseases. These diseases can manifest with conspicuous clinical symptoms or remain entirely silent, resulting in unexplained deaths. The cycle of life is frequently disrupted by accidents or intentional violent acts (violent deaths).
2. **Classification of Psychological Disorders - Bio-Psycho-Social Model:** Historical Evolution of Psychiatry, Classification of Psychiatric Disorders (Anxiety Disorders, Dissociative Disorders, Delusional Disorders, Personality Disorders, Paraphilias, Mood Disorders, Habit and Impulse Disorders, Schizophrenia, Somatic Disorders, Phobias, Parental Alienation Syndrome, Technological Anxiety, Psychosis, Psychogenic Bulimia, Mood Disorders in Children and Adolescents, Dementia), Bio-Psycho-Social Model.
3. **Law and Justice - Courts and Institutions - Violence Management and Intervention:** Concept and Historical Overview, Fundamental Distinction of Legal Branches. Elements of Legal Process and Justice System, Elements of Criminal Law. Violence Management and Intervention (from the pre-investigative phase to the courtroom), Violence Management and Intervention by the Forensic Expert, Psychiatrist, and Psychiatric Forensic Expert.
4. **Theories of Human Behavior - Dependencies and Deviance:** Behavioral Theory, Cognitive Theory, Systemic Theory, Personality Theories. Communication with Personality Disorders - Crime and Dependency. The number of drugs and substances with effects on the human CNS is vast, with over 3,000 formulations for hypnotics alone. Consequently, an attempt will be made to categorize them, outlining their dependencies.
5. **Sexual Offenses: Forensic - Psychiatric Child and Adolescent Forensics – Child Abuse:** A significant percentage of minors and adults fall victim to sexual assault. In many of these cases, physical abuse accompanies sexual abuse. Various theories have been developed to explain sexual aggression and rape. This section will discuss sexual violence (rape, epidemiology, clinical characteristics of perpetrators, biological background of individuals with sexual aggression, paraphilias, pedophilia-internet, rape and early traumatic experiences and deviance, autism spectrum disorders, ADHD and deviance, parental capacity), causation, and therapeutic interventions. Involuntary hospitalization.

6. **Complications - Medical Error - Medical Negligence by Medical Specialty:** Negligence and error in medical practice. In every organized society, human relationships and transactions are often subject to harmful consequences that may arise from acts or omissions in the exercise of any professional activity, which, depending on the circumstances, establish the potential liability of the professional, in our case, the doctor. In these cases, the patient suffers "damage" due to medical error resulting from demonstrated "negligence" on the part of the healer. However, complications that are documented by various scientific organizations and communities for each medical specialty can also occur. In this specific section, we will discuss Complications - Medical Errors - Medical Negligence by Medical Specialty, each separately for different medical specialties with examples of specific incidents.
7. **Forensic Data - Criminological Perception of Violence:** Forensic and toxicological data and findings. Criminological Issues (how crime is presented and how criminal phenomena are depicted, significant developments and key research findings on female, male criminality, and juvenile delinquency in the modern era. Criminology as the field of ultimate conflict between the psychological forces and potential of human free existence), Ethics, and Deontology in Forensics, Psychiatry, Child Psychiatry.

2nd Semester

1. **Mental Disorder - Psychological Disorders and Delinquency - Forensics:** It is clear that individuals with intellectual disabilities commit crimes, but it is not at all clear whether this happens in a greater proportional ratio than in the general population. The male gender is typically responsible for a higher percentage of delinquency than the female gender. In this specific section, we will discuss the assessment and estimation of danger, positive symptoms and attribution, negative symptoms and attribution, victimization, emotional disorders and delinquency, PTSD, anxiety disorders, dementia and victimization, sexual delinquency, arson, self-destructive behavior, anger and aggression. The freedom of private will as the foundation of forensics presupposes the individual's physical ability for the free formation of their will. Autonomy of private will, free self-determination, and legal capacity of the individual (legal capacity, legal incapacity, capacity to write a will).
2. **Ethics - Bioethics in Forensics - Psychiatry:** Aristotelian ethics, bioethics in Forensics - Psychiatry, stigma of Mental Disorders, general medical ethics and deontology, classical and contemporary directions in psychiatric ethics, development of psychiatric ethics (modern codes of medical ethics-psychiatric ethics, peculiarities of psychiatric ethics).

3. **Management - Violence Management:** Violence against minors and adults is a widely prevalent phenomenon in all societies. Violence includes physical, verbal, sexual, psychological / emotional harm or injury to someone's health, neglect, the coercion. In this specific section, management of violence within the family and all social groups context will be discussed. Management within the framework of Psychiatry Clinic, Profiling, Terrorism.
4. **Physical Harm - Forensic Medicine and Law - Animal Abuse:** Articles of the penal code and the code of criminal procedure that govern Forensic Medicine for Physical Human Harm and Animal Abuse. Impulse control disorders and attribution, somatic disorders. Injuries caused by striking, stabbing, cutting organs, and physical harm caused. Examples of forensic incidents. Animal abuse.
5. **Personality Disorders - Crime and Theories of Aggression:** Antisocial personality disorder, Borderline personality disorder, Psychopathy-Dangerousness. Psychoanalytic approach (basic principles of psychoanalytic approach, instincts of life and death, structure of the psychic apparatus with the distinction between conscious, subconscious, and unconscious - analysis of ego defense mechanisms), Neurobiological approach to disorders of the paranoid spectrum. According to modern taxonomic systems, which conceptually approach diagnostic entities (paranoid schizophrenia, delusional disorder, and paranoid personality disorder), genetic data that contain unique information for each individual and their psychological composition - Hereditary, genetic causes.
6. **Presence in Court - Expert Witness and Trial:** The role of the Expert Witness in the trial, Attribution/Partial Attribution in Criminal Trial. Writing an Expert Opinion for Civil Trial. Writing an Expert Opinion in disputes over child custody. Writing an Expert Opinion for cases of the law on narcotics. Examination and formulation of opinion by an expert witness. Expert witness: a person capable of giving an opinion on a matter related to their expertise or experience. The latter means that you must be an expert, experienced, and skilled with many years of practice in your field. Expertise must be based on adequate scientific and technological methods - laboratory tests in this case. Just like in every case in medicine, you start or must consider the patient's or deceased's medical history.
7. **Research in Forensic Psychiatry - Interesting Cases:** Guidelines for writing a thesis. Presentation of Forensic and Psychiatric cases, assuming that their cases have been concluded and finalized. Methodology of research in Forensic Medicine.

3rd Semester

Master's Thesis

The Master's Thesis aims to introduce the student to scientific research and/or scientific literature, with the disclosure of their results, both in writing and orally, in accordance with the prevailing standards of the international scientific community. Its subject is the review of scientific literature and the presentation of its results in the scientific field of the MSc program.

MASTER'S THESIS GUIDELINES

For the completion of the Master's Thesis, the Coordinating Committee (after the candidate's application on specified dates, including the proposed title of the master's thesis, the proposed supervisor, and the abstract of the proposed work) appoints the supervisor. Simultaneously, a three-member Examination Committee is established to approve the work. The members of the Committee can be faculty members, instructors, or visiting instructors (domestic or international) with expertise in the subject matter of the Master's Program.

Change of the supervisor can only occur under exceptional circumstances, with a request from the supervisor or the master's student and approval from the Coordinating Committee of the Master's Program and the Assembly. Once the three-member examination committee is formed, the supervisor may be replaced by one of the remaining members of the committee or by another faculty member proposed by the Coordinating Committee of the Master's Program and approved by the Department Assembly.

The presentation of the Master's Thesis is conducted before the three-member Examination Committee on a date and location determined by the Department Assembly, either in person or online. After approval by the Committee, the thesis is mandatory posted on the relevant School's website. To support the Master's Thesis, the graduate student may attend provided they have successfully completed all course examinations and settled their tuition fees.

The thesis can be a research or systematic review study. In both cases, there will be a detailed explanation of the specific selection of references and formulation of a specific research question based on identifying a gap in the literature. **The structure** of the thesis will include: abstract, introduction, methodology and materials, results, discussion, conclusion. The writing of the thesis can be carried out in the English language with the option of its submission for publication in an international scientific journal.

To approve a Master's Thesis, it must meet the following requirements:

- The topic and content of the work must be relevant to the subject of the Master's Program.
- The thesis must be original.

The Department Assembly can extend the writing and submission time of the Master's Thesis by one year. The submitted work is evaluated no later than three months from its submission. If this deadline is exceeded, the topic is removed from the list, and the study cycle is considered incomplete.

Changing a candidate's thesis topic is possible only with a recommendation from the Coordinating Committee of the Master's Program and approval from the Department Assembly, following a reasoned proposal from the supervising professor. Changing the thesis topic leads to an extension of the above-mentioned deadlines, only after approval from the Department Assembly.

Once the preparation and writing of the thesis are completed, it is submitted in four copies to the Secretariat of the Master's Program, along with the supervising professor's endorsement that it meets the prerequisites for review. **The date for the oral examination** is determined by the Coordinating Committee. The Master's Thesis is evaluated by the supervisor and the two other members individually. The average of the three evaluators' grades is the final grade of the Master's Thesis.

A graduate student who has passed all course examinations and successfully presented their thesis is awarded the Master's Degree with the title 'Forensic and Psychiatric Sciences.'

The Master's Degree grade is calculated as the weighted average of the courses of the Master's Program and the Master's Thesis (weighted according to ECTS credits).

The formula is:

Master's Degree grade = sum of (course grade x ECTS credits for each course) + (Master's Thesis grade x ECTS credits). The final grade is rounded to the second decimal place.

The transcript is submitted to the Secretariat of the Master's Program immediately after the completion of the evaluation process for the graduate students.

A copy of the master's thesis is electronically sent to the Central Library, following the provided format guidelines, by the Library and Information Center of Aristotle University of Thessaloniki.

MASTER'S DEGREE OF THE POSTGRADUATE PROGRAM / OATH-TAKING CEREMONY

The Master's Degree of the Postgraduate Program is a public document with the title "Forensic Medicine, Forensic Psychiatry Forensics," awarded to graduates by the School of Medicine, Aristotle University of Thessaloniki.

It is issued electronically by the Secretariat of the Postgraduate Program. The Degree includes the Department which organize the Postgraduate Program, along with emblems of the institution, the year of completion of studies, the issuance date of the Degree, the graduation protocol number, the title of the Postgraduate Program, the details of the postgraduate student, and the evaluation classification: "Satisfactory," "Very Good," "Excellent."

A Certificate of Successful Completion and Graduation from the Program may be granted to the graduate of the Master's Degree before the official conferment. In addition to the Master's Degree, a Diploma Supplement is issued, which is an explanatory document providing information about the nature, level, general framework of education, content, and status of the completed studies. This document does not replace the official academic title or the detailed course grades issued by the Institutions.

The Diploma Supplement, the certificate accompanying the Master's Degree in "Forensic Medicine, Forensic Psychiatry " is provided in both greek and english language.

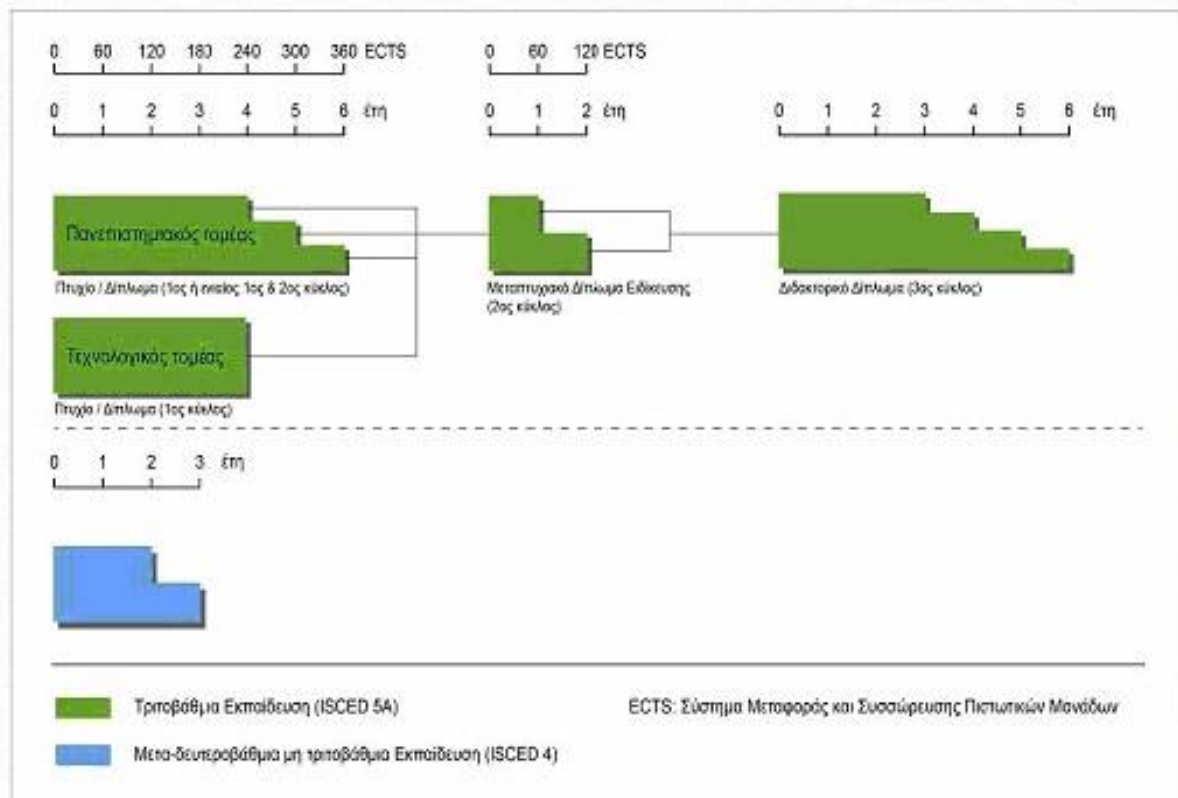

Το σύστημα εισαγωγής στα Ιδρύματα Ανώτατης Εκπαίδευσης βασίζεται στις προγραμματισμένες διαθέσιμες θέσεις (numerus clausus), στη σειρά προτίμησης σχολών/τμημάτων από τους υποψηφίους και στο Γενικό Βαθμό πρόσβασής τους. Για ορισμένες σχολές απαιτείται εξέταση και σε ειδικά μαθήματα (π.χ. Σχέδιο για την Αρχιτεκτονική) ή πρακτικές δοκιμασίες.

Τα προγράμματα σπουδών σε σχολές/τμήματα των Ιδρυμάτων Ανώτατης Εκπαίδευσης, διαρκούν -ανάλογα με το αντικείμενο- από τέσσερα έως έξι έτη, και η ολοκλήρωσή τους παρέχει το αντίστοιχο Πτυχίο /Δίπλωμα. Η απόκτηση του τίτλου αυτού οδηγεί στην αγορά εργασίας, ενώ ταυτόχρονα δίνει τη δυνατότητα πρόσβασης σε σπουδές μεταπτυχιακού κύκλου, δηλαδή: σε σπουδές του 2ου κύκλου που οδηγούν στο Μεταπτυχιακό Δίπλωμα Ειδίκευσης (ισότιμο με πτυχίο Master's) και του 3ου κύκλου που οδηγούν στο Διδακτορικό Δίπλωμα.

Η νομοθεσία για τη διασφάλιση της ποιότητας στην Ανώτατη Εκπαίδευση, το Σύστημα Μεταφοράς και Συσώρευσης Πιστωτικών Μονάδων (ECTS) και το Παράρτημα Διπλώματος καθορίζει το πλαίσιο των διαδικασιών και των κριτηρίων για την αξιολόγηση των Ιδρυμάτων της Ανώτατης Εκπαίδευσης, καθώς και για την πιστοποίηση των σπουδών των φοιτητών. Τα μέτρα αυτά στοχεύουν, μεταξύ άλλων, στην ενίσχυση της κινητικότητας των φοιτητών και συμβάλλουν στη δημιουργία του Ευρωπαϊκού Χώρου Ανώτατης Εκπαίδευσης.

Λεπτομερής περιγραφή του ελληνικού εκπαιδευτικού συστήματος υπάρχει και στον Εθνικό Φάκελο που συντάχθηκε από την Ελληνική Υπηρεσία του Ευρωπαϊκού Δικτύου για την Εκπαίδευση ΕΥΡΥΔΙΚΗ.

Students admission is based on a rating of their documented qualifications and interview.

4. INFORMATION OF THE CONTENT AND RESULTS GAINED**4.1 Mode of study:** Full-time

Part-time attendance is provided only to students who are proven to be working at least 20 hours a week, or in severe cases as illness, workload, serious family reasons, military conscription, reasons of force majeure.

4.2 Programme requirements:

For the acquisition of the Postgraduate Specialization Degree "ForensicMedicineForensicPsychiatry", postgraduate students are required to successfully complete the 3-semester course, which corresponds to 90 ECTS (Ministerial Decision 67145/B7, Hellenic Government Gazette 1889/2007/B7). They have to attend and be successfully examined in 14 subjects (Background-General Knowledge, Scientific Field, Skills Development), which are allocated as follows: a) In the 1st semester (30 ECTS) - 7 subjects and b) In the 2nd semester (30 ECTS) - 7 subjects. In the 3th semester (30 ECTS) they design and accomplish their Postgraduate Thesis, which they present in public and, subsequently, are examined.

8. INFORMATION ON THE NATIONAL HIGHER EDUCATION SYSTEM

Pursuant to the Constitution (article 16, paragraph 5), Greek Tertiary Education is public and gratis. Furthermore, according to the legal framework, it is divided into:

- (a) the University sector (A.E.I.): Universities, Technical Universities, Fine Arts School, etc., and
- (b) the Technological sector (T.E.I.): Technological Education Institutions and the School of Pedagogic and Technological Education.

Part of the University sector is also, since 1998, the Greek Open University, which provides open and distance -undergraduate and postgraduate- education and training.

There are also state post-secondary non-tertiary Institutions offering vocationally oriented courses of shorter duration (2 to 3 years), which operate under the authority of other Ministries.

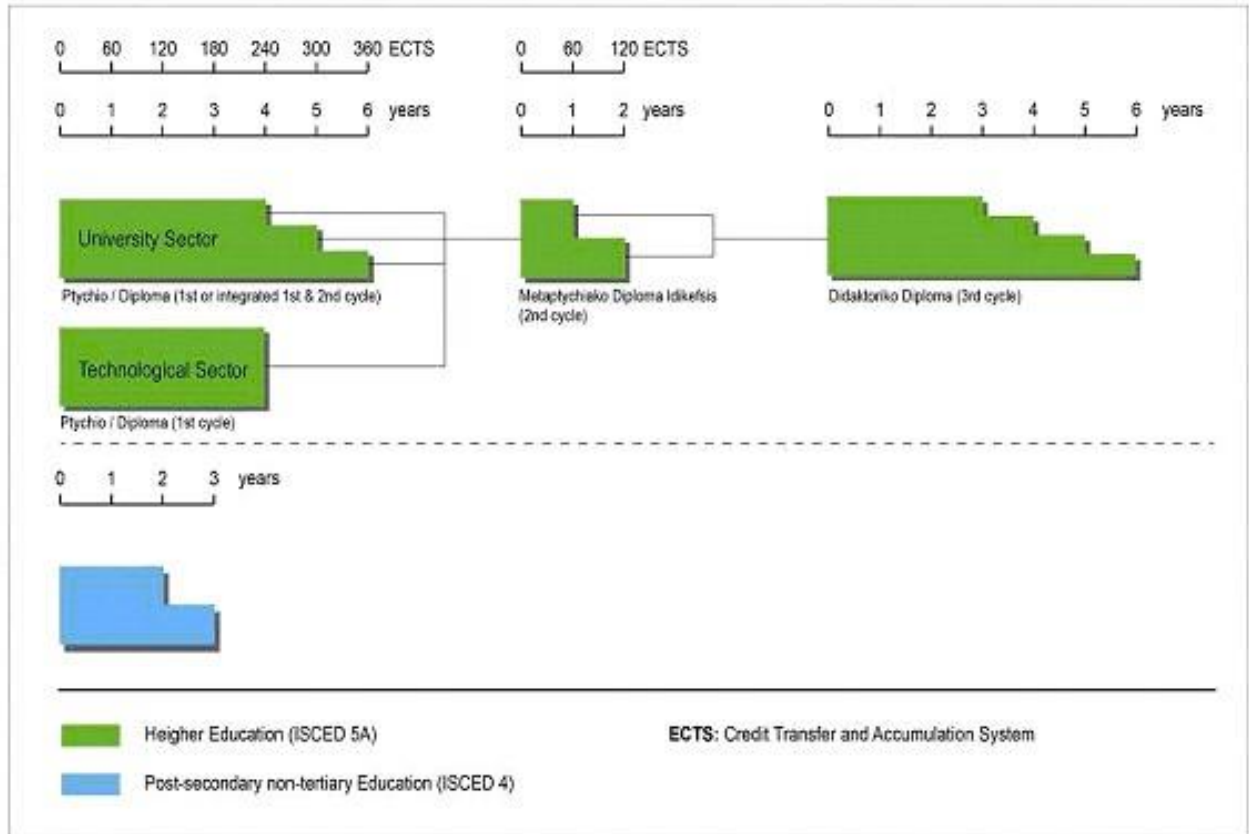
All graduates of secondary education (Geniko and Epagelmatiko Lykeio) can be admitted to Higher Education Institutions, depending on the general score obtained in national examinations that take place at the end of the final year of Lyceum. The admission system is based on the number of available places (numerus clausus), the candidates' performance, and the candidates' ranked preferences of Schools. Admission to particular schools may also require a special examination (eg drawing for Architecture, etc.).

Study programmes in Higher Education Institutions last from four to six years, depending on the subject area. Students who successfully complete their studies are awarded a Ptychio / Diploma, which permits employment or further studies at post-graduate level leading to a Metaptychiako Diploma Eidikefsis (2nd cycle) - equivalent to the Master's degree- and to the doctorate degree (3^d cycle), Didaktoriko Diploma.

Legislation on quality assurance in Higher Education, the Credit Transfer and Accumulation System (ECTS) and the Diploma Supplement defines the framework and the criteria for the evaluation of Higher Education Institutions, and for the certification of programmes of studies. These measures aim, among others, at promoting student mobility and contributing to the creation of the European Higher Education Area.

Degree Conferral / Graduation Ceremony

The oath-taking ceremony is not a mandatory component for the successful completion of studies, but it is a necessary requirement for the issuance of the diploma. The conferral ceremony takes place within the Assembly of the School, in the presence of the Program Director, the Department Chair, the Dean or Deanship of the School, or their respective deputies, and subject to the availability of the Rectorial Authorities of Aristotle University of Thessaloniki.

Postgraduate students who have successfully completed the Master's Program, under exceptional circumstances (such as studies, residence, or work abroad, health reasons, etc.), can apply to the School's / Department's Secretariat for an exemption from the obligation of attending the conferral ceremony.

LEARNING OUTCOMES

With the completion of the MSc program in "Forensic Medicine - Forensic Psychiatry" graduates will have achieved the following learning outcomes:

- Acquire the skills necessary for organizing both theoretical and empirical investigations based on the topics covered in the MSc program, which will advance their scientific knowledge in the field of "Forensic Medicine, Forensic Psychiatry" as well as legal issues arising from the interdisciplinary nature that governs the application of principles from both knowledge domains.
- Gain knowledge and skills in managing dangerousness, violence, and related behaviors exhibited by mentally ill individuals.
- Strengthen the qualifications and necessary skills of professionals for successful careers in the private, public, and academic sectors.

RIGHTS AND OBLIGATIONS OF POSTGRADUATE STUDENTS

Within the framework of enrollment in the Postgraduate Program:

The postgraduate student is obligated to attend all courses each semester. Course instruction entails an in-depth presentation of specialized topics within the field of knowledge, either through the lecturer's comprehensive presentation, interactive discussions, assignment submissions, research project development, and/or any other method that, at the discretion of the lecturer, contributes effectively to the acquisition of scientific knowledge and facilitates learning.

Postgraduate students of the Postgraduate Program are required to consistently participate in the program. If significant reasons prevent physical attendance in a course, students are allowed to be absent for up to 20% of the total course instructional hours. Otherwise, the postgraduate student is obligated to retake the course during the following academic year. This matter is reviewed by the Student Evaluation Committee, which provides its opinion to the Program Committee of the Department of Medicine.

In cases of unforeseen circumstances or force majeure, examinations may be conducted using electronic means, ensuring the integrity of the evaluation process.

In instances of illness, the instructor is encouraged to facilitate alternative evaluation methods for the student (e.g., oral or remote examination).

If a postgraduate student fails a course examination, for instance, twice, and is deemed not to have successfully completed the program, an application for reevaluation can be submitted to a three-member committee composed of Academic and Research Staff of the Department. These members possess expertise in the subject matter of the course and are appointed by the Department Assembly. The responsible instructor for the examination is excluded from this committee.

Furthermore, postgraduate students are obligated to:

- Participate in all educational and research activities.
- **Communicate via their institutional account - @auth.mail and regularly check for updates and announcements from instructors.**
- Submit assignments within the prescribed deadlines for each course.
- Attend examinations.
- Submit a signed statement, along with their thesis, to the Secretariat, confirming the absence of plagiarism.
- Pay tuition fees within the specified dates.
- Settle all financial obligations and any other obligations to the institution prior to the conferral ceremony. Otherwise, they will be ineligible for the graduation ceremony and/or the receipt of the postgraduate diploma.
- Pursue concurrent enrollment in both an undergraduate and a postgraduate program or in two (2) Postgraduate Programs, either within the same or different departments of the same or different universities.
- Respect and adhere to the decisions of program authorities as well as academic ethics. Failure to comply without valid documented reasons may result in course failure or expulsion from the program.

- Evaluate courses and instructors of the Postgraduate Program (anonymously) at the end of each semester, following the announcement by the Quality Assurance Unit.
- After the presentation of their thesis and before the conferral, deposit or submit a copy to the Central Library of Aristotle University of Thessaloniki in accordance with the library's standards and guidelines.

Non-adherence to all the above, without significant and substantiated justification, may lead to the removal of the postgraduate student from the program.

In the aforementioned cases - and following a substantiated recommendation from the supervising professor - the Coordinating Committee can propose and decide on the student's removal.

Evaluation of Instructors and Courses by Students

With the exclusive purpose of enhancing the quality of the Master's Program studies and ensuring complete anonymity, students are required to engage in the evaluation of courses and instructors every semester.

For the sake of uniform statistical data collection and the possibility of deriving useful conclusions for the educational work of the Departments and the Institution as a whole, the evaluation questionnaires are prepared by the Quality Assurance Unit (QAU). These questionnaires may vary partially based on the unique characteristics and needs of each academic unit and/or course. They are electronically completed using the student's institutional account and remain anonymous.

Tuition Fees

- A total tuition fee of four thousand (€4,000) is payable for enrollment in the Master's Program. The amount and method of tuition fee payment may be adjusted based on the proposal of the Coordinating Committee of the Master's Program, the decision of the Department Assembly of the School of Medicine, and approval from the Senate of the Aristotle University of Thessaloniki (AUTH).
- Tuition fees are paid by the student (or by a third party, natural or legal person, on behalf of the student) to the bank account of the Special Account for Research Funds of AUTH, in two equal installments: the first installment upon enrollment and the second installment before the start of the second semester. After payment, a receipt is issued, and the student is notified electronically.
- Master's students whose individual or family income does not exceed one hundred percent (100%) of the national median equivalent income are **exempt from tuition fees**. Family income should not exceed seventy percent (70%) of the national median equivalent income. Exempted students

should not exceed thirty percent (30%) of the total number of students admitted to the Master's Program. If eligible students exceed this percentage, they are selected based on ranking, starting from those with the lowest income.

- The Minister of Education, Research, and Religious Affairs, through an official announcement published in the Government Gazette, defines any issues related to the application of the law. Similarly, through such an announcement, the annual amount corresponding to the national median available equivalent income is determined (both individual and seventy percent (70%) of family income), according to data from the Hellenic Statistical Authority (ELSTAT). The income of the last fiscal year is taken into account by the Committee, considering that the tax clearance has been completed at the time of enrollment, following the provisions of the Income Tax Code.
- The application for tuition fee exemption is submitted by the interested student to the Department, after the completion of the selection process for Master's students. The possibility of exemption from tuition fees is exclusively provided for the enrollment in one (1) Master's Program organized by domestic Higher Education Institutions (HEIs). The financial status of the applicant shall in no case be the reason for non-selection in a Master's Program. Those receiving scholarships from other sources are not eligible for exemption.

Scholarships

It is possible, by decision of the Program Committee and depending on the program's revenue, to grant scholarships to postgraduate students. Scholarships are awarded based on academic and objective criteria (such as academic performance based on the average grade of the previous semester) and must be included in the approved budget of the Program.

The Regulations of Postgraduate Studies in the "Forensic Medicine – Forensic Psychiatry" Postgraduate Program provide for the granting of scholarships to postgraduate students based on academic and objective criteria, as determined by the Coordinating Committee. Scholarships are awarded in the following cases:

- Full scholarship, with a 100% tuition fee waiver, in the event that the Coordinating Committee deems the interview of the candidate excellent before selection.
- Excellence scholarship, with a 50% reduction in tuition fees, will be awarded to a student who completes the 1st semester of studies in the prescribed time and achieves the highest performance score. In case of a tie, the scholarship is granted to all students with the highest and equal score.

The terms of award, obligations, and rights of scholarship recipients are determined following a proposal by the Coordinating Committee.

The application for a scholarship is submitted to the Secretariat of the Master's Program **only once, at the beginning of the 1st semester** of enrollment and is evaluated by the Coordinating Committee of the Master's Program.

Academic Advisor

With the commencement of enrollment in the Master's Degree Program, a permanent member of the Teaching and Research Staff of the Master's Program is appointed as an Academic Advisor for each postgraduate student.

Their role is to provide necessary guidance to postgraduate students to meet the requirements of the Master's Degree Program. This is achieved through regular meetings, face to face or online and monitoring the progress of students' studies. The Academic Advisor also receives information from instructors regarding continuous absences of students under their responsibility. The Advisor informs the students (through the Program Secretariat) that such absences might result in course failure. Furthermore, the Academic Advisor assists students in selecting their Master's thesis topic, taking into consideration their research interests. Postgraduate students are obligated to communicate with their Academic Advisor for any issues that might impact the smooth progress of their studies.

Student Complaint Management Service

In the context of enhancing student-centered educational processes and the principles of transparency and accountability, the "Student Complaint Management Process" has been adopted for the postgraduate students of the Medical Department of Aristotle University of Thessaloniki (AUTH). This process covers all complaints related to the quality of educational services provided by the AUTH Medical Department's Master's Programs and operates as follows:

To document complaints and objections from Master's Degree Program students, the "Complaint Submission Form" is available both in print and electronic form, which students need to complete.

The Responsible Officer, upon reviewing the complaint, takes all necessary actions and informs the relevant bodies of the specific Master's Program on a case-by-case basis.

The Responsible Officer for Student Complaints is a member of the Teaching Staff of the Master's Degree Program and is appointed for a two-year term at the beginning of the academic year based on the proposal of the Coordinating Committee and approval by the Department Assembly.
